ORDER

The Provisional Affiliation for starting MBA and MCA programmes at West Fort Higher Education Trust (Unaided), Pottore, Thrissur during the academic year 2004-05 with an intake of 60 students each vide University Order read as 1st.

The name of West Fort Higher Education Trust, Pottore, Thrissur has been changed to 'Institute of Management and Technology', Thrissur with effect from 2012-13 vide University Order read as 2nd.

The Continuation of Provisional Affiliation was granted to MBA & MCA courses for the academic year 2014-2015 vide U.O.read as 3rd.

The Principal, Institute of Management and Technology, Thrissur, as per the letter read as 4th, has requested to grant Continuation of Provisional Affiliation to the above courses for the academic year 2015-16.

The college has remitted an amount of 2,40,000/- (Rupees Two Lakh and Fourty Thousand only) as Administration and Affiliation fee vide Chalan Nos. 151414284 & No.151414292 dt.14.5.2015 at Friends Janasevanakendram, Thrissur. The All India Council for Technical Education has extended its approval for the academic year 2015-16 vide letter read as 5th & 6th.

Sanction has, therefore, been accorded by the Vice Chancellor on 03-06-15, for granting Continuation of Provisional Affiliation to the following courses for the academic year 2015-16

at Institute of Management and Technology, Thrissur.

Affiliation granted is strictly Provisional and only for the academic year 2015-16. Continuation of Provisional Affiliation for the ensuing years should be obtained after applying the same along with required fee and extension of approval order from the apex body concerned. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the basis of the directions issued by the University and Government from time to time, failing which the affiliation granted will automatically be cancelled.

In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the college will be initiated.

Admission to the next academic year shall be made only after obtaining prior permission from the University.

Orders are issued accordingly.
